



What is the Minbanc Foundation?

An IRS 501 (c)(3), Minbanc Foundation is an education non-profit formed in 1999 to support increased opportunities for training and professional development in the minority banking community.

What does Minbanc Foundation do?

Minbanc supports diversity in bank management, workforce development, and financial education through an employee Education Grant program.

Up to \$3,000 a year is available to the employees of each minority- and women-owned bank for bank-training through recognized industry providers (including national trade groups and State Bankers Associations).

What training does Minbanc support?

Since 1999, Minbanc has supported coursework such as:

- Compliance and regulatory training
- Graduate Schools of Banking
- Credit and Risk Analysis seminars
- Bank-Director Training
- Branch Management Schools
- Other advanced coursework related to the management of a financial institution

How are applicants evaluated?

- Bank must be recognized as “minority- or women-owned” (Minbanc follows the FDIC’s definition when evaluating applications)
- Employee attending training must be at the management or officer level
- Coursework must be of an advanced nature and specific to the management of a financial institution
- Only tuition at bank-focused training is covered (no travel, housing, etc. qualifies)
- Minbanc Foundation will only evaluate applications for coursework that has already been paid for and completed – thus ensuring Minbanc Education Grants are properly dispersed and distributed

Why support Minbanc?

- All donations are tax deductible
- 100% of your donation translates directly to Education Grants for the employees of eligible institutions
- Under current regulations, “furnishing financial services training” to minority- and women-owned banks could be considered a qualifying activity for CRA credit
